

Publication rules

JOURNAL “LA CULTURA DEL ÁRBOL”

All articles are subject to the following rules:

Title. Should reflect the content of the article and be as short as possible (no more than 30 words).

Authors. Full names of all authors. Profession, occupation and workplace. Postal address, email address and contact telephone number.

Summary. In short (less than 150) should summarize the article content.

Size and format of articles. They should not exceed 3,000 words. Written in Word (version 6.0 or similar) must be submitted to 1.5 spaces, in Times New Roman 12. The pages must be numbered.

Photographs. It is desirable to include a sufficient number of photographs that facilitate the understanding of the article and provide important information on the subject. They should be of the highest possible quality (300dpi), preferably in digital format (JPGE or TIFF). The text will be identified as follows: Picture 1, Picture 2, etc. in the place where it is considered appropriate to be located. Photographs are supplied in a separate document to the text, and each will have an explanatory caption.

Graphs and charts. They should preferably be sent in JPEG or TIFF format in a separate document. In the text the place where they should go will be indicated. Will be identified as Figure 1, Table 1... and the title or explanatory text for each is provided.

Text boxes. It will be possible to insert text boxes from the main text, provided that explain in detail any ideas or provide any specific and additional information.

References. It will include the strictly necessary. Appointments are indicated by a number in the text, putting all the bibliography at the end of the article (no footnotes page). For your appointment the following models will be followed:

Originality. The authors, because sending the article for publication in *La Cultura del Árbol* recognize the originality of it and that has not been published (nor submitted for publication) in another journal. The authors are responsible for obtaining the necessary permissions to reproduce copyright material from other sources.

Evaluation process. *La Cultura del Árbol* will confirm receipt of the manuscripts. The editorial board will decide on publication based on a minimum of technical quality and newsworthy. Manuscripts may be accepted provided that changes to the original are made according to the criteria of the reviewers and the editorial board. The editors reserve the right to make any final changes to help clarify the contents or improve the text style is reserved.

Authorization use website. The presentation of an article for publication in *La Cultura del Árbol* implies acceptance of these rules. Furthermore the author or authors authorize, because the article was published in the journal in its issue paper, to be published in PDF on the website of the Spanish Association of Arboriculture (Asociación Española de Arboricultura) if deemed appropriate.

Reprints and certificates. After publication, the author or first signatory of them, when are several, receive three printed copies of the journal and your article in PDF format. Also each signer will receive a certificate of authorship and publication.
